### **2. Minutes of Last Meeting**

2009 had seen the loss of a number of venues and some championship rounds. He commented that this situation does not look much better for 2010.

### **4. Secretary's Annual Report**

Membership of the Association remains almost constant with a small turnover of clubs. The Secretary thanked those clubs that do communicate and urged all clubs to keep him informed of changes to their officials – a form for this is on the Association's website<sup>1</sup>.

### **5. Treasurer's Annual Report**

The accounts had already been circulated.

Financially 2009 has been a good year with no exceptional expenses (compared with expenses associated with the 50<sup>th</sup> anniversary of the EMAMC in 2008). However interest rates have plummeted which has had a big impact on the Association's income from interest.

The surplus for 2009 was £1,300.

This compares with £464 in 2008.

The Association's balance is approximately £16,000.

The Treasurer requested the delegates accept the Annual Accounts. Notts SCC proposed acceptance, seconded by Eastwood DMC. Agreed unanimously.

### **6. Amendments to Constitution**

To change the closing date for nominations for Special Awards from 31<sup>st</sup> December to 30<sup>th</sup> November – proposed by Notts SCC, seconded by North Humberside MC. Agreed
